RESOLUTION APPROVING THE PROPOSED ADDENDUM TO THE STUDENT HANDBOOK FOR THE IMPLEMENTATION OF COMMISSION ON HIGHER EDUCATION MEMORANDUM ORDER (CHED CMO) NO. 18, 2018- THE IMPLEMENTING GUIDELINES FOR THE CONDUCT OF DRUG TESTING FOR STUDENTS IN ALL HIGHER EDUCATION INSTITUTIONS (HEIS)

- WHEREAS, the Board approved the CSU Student Handbook per BOR Res. No. 50-22, s.2019;
- WHEREAS, the Commission on Higher Education (CHED) issued CMO No. 18, s.2018- The Implementing Guidelines for the conduct of Drug Testing for students in all Higher Education Institutions (HEIs);
- WHEREAS, the said CMO mandates all HEIs to implement mandatory random drug testing to all tertiary level students pursuant to Section 36 (c) of Republic Act (RA) No. 9165 otherwise known as the "Comprehensive Dangerous Drugs Act of 2002";
- WHEREAS, based on the same CMO, an HEI in its exercise of academic freedom, may adopt and implement its own mandatory drug testing policies as a requirement for admission and retention;
- WHEREAS, provisions for the implementation of the same should be reflected in the school's Students Handbook;
- WHEREAS, the proposed addendum now include provisions for the implementation of CMO 18, s.2018 (as herein attached as Annex A);
- WHEREAS, the said proposal was presented during the Administrative Council Meeting on March 15, 2021 and was endorsed for the approval of the Board per Resolution No. 03-15-20, s.2021;
- WHEREAS, the same proposal was also presented to the Fiscal and University Development Program Review Committee (Fiscal-UDPRC) during its 41st Committee Meeting on March 19, 2021 and was favorably endorsed by the same Committee per Resolution No. 41-23, s.2021 subject to the comments and suggestions raised during the deliberation;
- WHEREAS, presented now before the Board for approval is the proposed addendum to the student handbook, specifically on the inclusion of provisions for the implementation of CMO 18, s. 2018;


